A RESOLUTION PROVIDING FOR A MEETING NOT OPEN TO THE PUBLIC IN ACCORDANCE WITH THE PROVISIONS OF THE NEW JERSEY OPEN PUBLIC MEETINGS, ACT, N.J.S.A. 10:4-12

RESOLUTION NO. 19-48 FEBRUARY 11, 2019

WHEREAS, the Borough of Woodcliff Lake is subject to certain requirements of the Open Public Meetings Act, N.J.S.A. 10:4-6, et seq., and WHEREAS, the Open Public Meetings Act, N.J.S.A. 10:4-12, provides that an Executive Session, not open to the public, may be held for certain specified purposes when authorized by Resolution; and WHEREAS, it is necessary for the Borough of Woodcliff Lake to discuss in a session not open to the public certain matters relating to the item or items authorized by N.J.S.A. 10:4-12b and designated below: Matters Required by Law to be Confidential. Any matter which, by express provision of Federal law or State statute or rule of court shall be rendered confidential or excluded from the provisions of the Open Public Meetings Act. 2. Matters Where the Release of Information Would Impair the Right to Receive Funds. Any matter in which the release of information would impair a right to receive funds from the Government of the United States. 3. Matters Involving Individual Privacy. Any material the disclosure of which constitutes an unwarranted invasion of individual privacy such as any records, data, reports, recommendations, or other personal material of any educational, training, social service, medical, health, custodial, child protection, rehabilitation, legal defense, welfare, housing, relocation, insurance and similar program or institution operated by a public body pertaining to any specific individual admitted to or served by such institution or program, including but not limited to information relative to the individual's personal and family circumstances, and any material pertaining to admission, discharge, treatment, progress or condition of any individual, unless the individual concerned (or, in the case of a minor or incompetent, his guardian) shall request in writing that the same be disclosed publicly. 4. Borough Attorney Schettino stated for the record that the Governing Body will be going into closed session for approximately 1 ½ hours to discussion litigation and personnel. The Governing Body will reopen this meeting and will take further public action once the meeting is reopened.

APPROVAL OF MINUTES

Motion to approve the Minutes of January 24, 2019 was made by Council President Gadaleta, second by Councilwoman Gross and approved by Councilman Belgiovine, Council President Gadaleta, Councilwoman Gross, Councilman Singleton and Councilman Spelling. Councilwoman Hayes abstained since she was not at the meeting.

MAYOR'S REPORT

Mayor Rendo stated that he had the pleasure of attending the grand opening of Bareburger with Councilman Singleton, Councilwoman Gross and Councilman Belgiovine. It is great to have another food establishment in Woodcliff Lake. It's good to have new tenants in town. Mayor Rendo wanted to thank the owners of Bareburger for being proactive and understanding the needs of the community. They treated us like gold. Mayor Rendo stated that he was invited down to Trenton by Governor Murphy on February 6, 2019 to attend the Alyssa Alhadeff Make our Schools Safe Bill signing. Mayor Rendo recognized all of the assembly people that worked on

this for years. Additionally, Mayor Rendo recognized Lisa Yakomin who has been very active to ensure that this bill is moved through the Assembly. Mayor Rendo thanked Governor Murphy for getting this Bill done. Mayor Rendo stated that on February 14th which is coming up will be the one-year anniversary of her death. The Governor was very gracious that we all were there. It was a somber moment.

Mayor Rendo asked that the Council direct our attorney, Mr. Schettino, to direct some guidance in terms of Committee assignments such as chairs, etc. Mayor Rendo stated that he spoke to former Mayors LaPaglia and Goldsmith and we have never as a Council appointed any Chair people to Committees. We have left that to the individuals that are on the Committees to appoint their chairs if they wish to do so. His personal opinion is that we should leave it up to the Committee to appoint their Chairperson. Mayor Rendo stated that if he does not appoint a person to a Committee after the advice and consent of the Council, should that person be included on emails concerning budgetary matters. That is a concern that he has.

Mr. Schettino stated that he is going to need some guidance from the Governing Body because it is discretionary. It is up to the Council's preference if they want to appoint the Chair of a Committee or if they want the Committee to appoint the Chair. Mr. Schettino stated that these appointments are one-year appointments. All Committees that are not established by Ordinance or a few Statutory Committees are one-year appointments. Mr. Schettino stated that the Council also must also advise him as to the purposes of the Committees.

Councilwoman Gadaleta stated that she thought it was an excellent idea that there is a purpose/role of the Committee. Councilwoman Hayes stated that ideally it would be great if the team could meet and pick their own Chair. However, regarding the Green Team, there are already questions coming from the Grant Writer regarding the Sustainable Jersey Grant. The grant is due on February 15, 2019 and we got the ball rolling but they need the help of some of the residents that are passionate about being on the Green Team. A part of being the Chair would be to set the Agenda, making sure the meeting is scheduled and taking the minutes of that meeting. Maybe we could do some sort of a hybrid model and at least assign a Chair for the Green Team. Mayor Rendo stated that he is making all the Committee appointments today. Councilwoman Hayes stated that she would like to add a Chair to the Green Team. Councilwoman Gross asked that if the Chair was made and after the first meeting it was decided that someone else be the chair, could it change. Mr. Schettino stated that if the Council appointed the Chair, and if were going to change it would have to come back to the Council. Mr. Schettino stated that if anyone had any suggestions with respect to the structure of a Committee, please email him so he could incorporate it. Mayor Rendo asked Mr. Schettino to come up with a description so they could work off it. Council President Gadaleta asked if there would be By-Laws for each Committee. Mr. Padilla stated that according to our By-Laws all the Committees report to the Borough Administrator.

Mayor Rendo appointed all members of the Committees as recommended by the Council (see attached) for a period ending on December 31, 2019. Members of the Council were all in favor.

Mayor Rendo stated that he received a phone call from a resident that lives adjacent to the Middle School and she has had some major flooding on her property. There was a point that her entire driveway was flooded, and they couldn't get out because it was so high. Mr. Padilla and Mr. Blackton went out to look at the property. The DPW cleared the leaves from the sewer so the water could drain. The problem is with a basin that is on the school property. Mr. Belgiovine stated that a garbage can was stuck in the basin. The basin is not being maintained by the school. Mr. Padilla will contact the school and advise them of the situation. Mayor Rendo stated that he will be attending a press conference on February 15, 2019 concerning the North Bergen Nuclear Power Plant. We passed a Resolution supporting the moratorium on the building of the North Bergen Nuclear Power Plant. This plant is going to be built solely for the benefit of New York City.

Mayor Rendo stated that we have so much talent regarding arts and creativity in this community. He thought it would be appropriate to create the Woodcliff Lake Council of the Arts. The purpose of this Committee is to promote the arts in Woodcliff Lake such as music, dance, sculpture, and art. Mayor Rendo stated that he would like to add this Committee called the Woodcliff Lake Council of the Arts and have Councilwoman Gross and Councilman Spelling as liaisons.

ADMINISTRATOR'S REPORT

Administrator Padilla stated that with reference to the school it has already been addressed. We have many issues/complaints with reference to drainage. The issue is a pipe on their property and it needs to be kept clear of debris. We have given them some advice on it. It is going to take more work on their part to address it. Mr. Padilla reported that 77 Brookview is complete. The resident was concerned as to the final solution, but they explained why it had to be built the way it had to be. There is some finishing work to occur up there because of the length of time that this was going on. We will need to do some landscaping in the spring. We continue to proceed with Galaxy Gardens. The bids for remediation are due back on February 20th at 10:00 AM. Mr. Padilla stated that he is hoping to have the introduction to the Salary Ordinance at the first meeting in March. This Ordinance is just the minimum and maximum, not the actual salaries of employees. We hope to have a candidate for the building department as well.

COUNCIL MEMBERS COMMENTS/REPORTS

Councilwoman Hayes had a quick finance update. The Finance Committee met with the Clerk, Police, Fire, DPW, Buildings and Grounds and Parks and Recreation. We have a few smaller departments left on the schedule and then we should have something ready by late spring. Councilman Singleton stated that they are hoping to have the Capital Budget ready for some time in March. Councilwoman Hayes thanked Mr. Padilla and Mr. Schettino regarding vacant properties in town. Mr. Schettino was able to get a draft Ordinance ready for the Council to look at. Mr. Padilla stated that he will send the Ordinance out to all Council members this week.

Mr. Singleton asked Mr. Padilla about the status of the chrome books. Mr. Padilla replied that he will follow-up with it.

Council President Gadaleta read a letter from former Councilwoman Herrington thanking the DPW for helping her with the transport of plastic bags from the school to Acme. Council President Gadaleta stated that our first Shredding Day will be March 30, 2019 from 9:00 AM to 12:00 PM. Fencing at the Ecology Center has been finished. DPW will be transporting the plastic bags from Dorchester to Acme to assist with the program and this will end in April.

Councilwoman Gross stated that there are some Resolutions on the Agenda for Parks and Recreation. A Resolution is on there that will allow grandparents to register their grandchildren for camp. Councilwoman Gross stated that the Wellness Challenge will begin on April 6th and go on for 9 weeks. We hope that many of our residents will take advantage of the opportunity to make health and wellness a priority. As for the police, they are going through the interview process for the lieutenant. They are review resumes for the new hire. Officer Matovski was just accepted into the Regional SWAT team. On March 28, 2019 the Police will be celebrating their

65th Anniversary at the Tice Center from 11:00 AM to 2:00 PM. Councilwoman Gross stated that we have a date for Unity of the Valley event. The date is March 19th at the Pascack Valley High School at 7:00 PM. We have a new Committee called the Community Outreach Committee. The purpose of it is to provide support to community members in times of need. Hopefully this will be our largest Committee with many volunteers helping our neighbors in times of need.

Mayor Rendo asked Councilwoman Hayes and Councilwoman Gross to see if we can contact Suez Water and see if we could open certain parts of the walkway for the Mayors Wellness Challenge and have an educational component.

Councilman Spelling stated that he is now on several Committees and he is looking forward to talking about those in the future as he works with everybody and gets his feet in the trenches on this.

JANUARY ENGINEER'S REPORT BOROUGH OF WOODCLIFF LAKE FEBRUARY 11, 2019



1. Bank Stabilization and Outfall Reconstruction at 77 Brookview Drive

The Borough recently award an emergency site work contract to Tomco Construction to remedy the formerly unstable condition at the site, and to construct the bank stabilization wall and new outfall. Tomco has satisfactorily completed all work under their emergency contract. Tomco mobilized to the site on January 7, and as of Thursday February 7, their portion of the site work was complete, and they have demobilized. NEA will be coordinating with the Borough and the property owners regarding the landscaping and restoration work to be performed in the rear yard, which was removed from the emergency work contract. It is anticipated that bid documents for this restoration work would be prepared during the winter, with public bidding occurring in late winter/early spring so that work can begin as soon as the weather permits.

2. Galaxy Gardens - Phase I - Soil Removal and Blending

The Soil Removal and Blending contract was put out to public bid on January 14. Two pre-bid site walk-through meetings were held at the site, on January 24 and February 7. As of February 8, 17 contractors (and 1 bid publication service) picked up bid documents from our office. Approximately eight of those bidders attended the pre-bid meetings, though attendance was not mandatory. Sealed bids are due to the Clerk before February 20 at 10:00 AM, at which point the bids will be opened and read aloud. NEA will provide a complete review of the submitted and opened bids, including an executive summary and a bid tabulation to the Governing Body prior to the next work session.

3. Glen Road Rock Slope

NEA was requested by the Borough to investigate an existing rock slope which appears to falling rocks that end up in the Glen Road roadway. NEA is coordinating with a geotechnical engineering sub-consultant to provide a proposal to rectify the rock issue. Due to the slope's location immediately uphill of the Bear Brook, NEA anticipates that NJDEP Land Use permitting will be required. NEA will provide a proposal for this work prior to the next work session.

4. Lincoln Avenue Roadway Improvements

NEA understands that the Borough received a grant to reconstruct a portion of Lincoln Avenue for the portion of the road within the Borough of Woodcliff Lake. A portion of the roadway also falls within the Borough of Hillsdale as well. NEA understands that the Borough reached out to Hillsdale to inquire about performing a joint roadway project to ensure the entire roadway is paved, rather than just the portions within Woodcliff Lake. NEA understands that Hillsdale is interested in joining in on this project with Woodcliff Lake. NEA will coordinate with the Borough Administrator regarding the joint effort between both municipalities.

5. Maria Road Pumping Station Improvements

NEA understands that the Borough intends to perform upgrades and improvements to the existing Maria Road sanitary pumping station. At the request of the DPW, NEA attending a meeting with the DPW and Rapid Pump, the Borough's pumping systems vendor. NEA understands that the Borough may partake in a co-op in order to have the work done by Rapid Pump, as a pre-approved contractor. However, based on preliminary research, it appears as if there are freshwater wetlands immediately adjacent to the pumping station. As such, any excavation or vegetation disturbance in this area would require NJDEP Land Use permitting. However, in order to determine exactly what permitting is required, Rapid Pump would need to provide a full proposal inclusive



of their exact scope and limit of work. Once received, NEA can prepare a proposal to prepare the required plans and documents to obtain the necessary permits.

6. Resident Drainage Complaint - 51 Saddle River Road (Kosoff)

NEA was previously requested by the Borough to investigate a complaint regarding stormwater runoff onto private property. NEA has investigated such on two occasions. Additionally, the property owner submitted a letter to the Governing Body with multiple questions regarding their drainage concerns. NEA is in the process of preparing a response to these questions and will provide such to the Mayor and Council upon completion.
