

BOROUGH OF WOODCLIFF LAKE MAYOR AND COUNCIL MEETING MINUTES JUNE 20, 2022 6:00 PM CLOSED SESSION 7:00 PM OPEN SESSION

CALL TO ORDER

Notice of this meeting, in accordance with the "Open Public Meetings Law, 1975, C. "231", has been posted at the Borough Hall and two newspapers, <u>The Record</u> and <u>The Ridgewood News</u>, have been notified.

ROLL CALL

Mayor Rendo asked for a roll call. Council members Gadaleta, Higgins, Margolis and Schnoll were present. Borough Attorney John Schettino, as well as Borough Administrator Tomas Padilla and Borough Clerk Debbie Dakin. Councilman Falanga and Councilwoman Hayes were absent.

CLOSED SESSION

Resolution No. 22-145

MOTION to approve Resolution No. 22-145 was made by Councilwoman Margolis, second by Councilwoman Higgins and approved by Council President Gadaleta, Councilwoman Higgins, Councilwoman Margolis, and Councilman Schnoll.

PLEDGE OF ALLEGIANCE

All present recited the Pledge of Allegiance.

APPROVAL OF MINUTES

Motion to approve the Minutes of June 6, 2022 (Open) was made by Councilman Schnoll, second by Council President Gadaleta and approved by Council President Gadaleta, Councilwoman Higgins, Councilwoman Margolis, and Councilman Schnoll. Councilman Falanga and

Councilwoman Hayes were absent.

Motion to approve the Minutes of June 6, 2022 (Closed) was made by Councilman Schnoll, second by Councilwoman Higgins and approved by Council President Gadaleta, Councilwoman Higgins, Councilwoman Margolis, and Councilman Schnoll. Councilman Falanga and Councilwoman Hayes were absent.

Mayor Rendo stated that for those residents that are tuning in, we did receive your emails concerning the Sony property. This will be addressed after we hear your concerns. We will have a special presentation by the landscape architect for Galaxy Gardens.

PUBLIC COMMENT

MOTION to open to the public was made by Councilwoman Higgins, second by Councilman Schnoll and unanimously approved.

Andy Roth, Woodcliff Lake, stated that his concern has to do with the proposed development in Park Ridge and Montvale. We have talked about this in the past and we now need some sort of action. His concern is the amount of development going on there. Not only is it physically impacting the land, but it will impact traffic considerably and other factors.

Kim LaRose, Woodcliff Lake, stated that her property backs directly up to the Sony property. Their largest concern in addition to what Andy had said is the proposed 30-foot setback for the building. They have about sixty feet of natural vegetation that sits right behind their property line and this goes across to all the neighbors who directly border the property. In the past, the regulation has been a 100-foot setback for building. Park Ridge was able to get a variance to build it thirty feet. They are already seeing considerable amount of flooding since they began excavating the project. All the yards have flooded like they never have before. They are hoping that the town will have some ability to assist them in helping maintain that natural vegetation that is behind their house. They received a certified letter from the DEP to submit any complaints or concerns to them regarding the environmental impact that this development may have. Mayor Rendo asked Ms. LaRose to forward the letter to Mr. Padilla.

Carol Murphy, Woodcliff Lake, stated that she loves everything about this town. She is aware that you cannot control development. She believes that we need to do something to keep it one hundred feet back. We cannot stop the development but maybe through the DEP we could do something. We did go to other meetings in Park Ridge and voiced our opinions and they told people to go to the August meeting and then they said that it is a done deal. They tried to the best of their ability and now they are reaching out to the town to try and keep some of the small town feel that Woodcliff Lake is.

Ann Marie Borrelli, Woodcliff Lake, stated that she does not know how far along the Causeway project is, but she was wondering if there could be two sidewalks instead of one. Sometimes when there are a lot of people walking it gets kind of tight and sometimes the cars drive close to

the edge. Will there be a sidewalk on both sides of the causeway? Mr. Padilla replied that at this moment that the way the bid specs were put out and awarded, it is only the one side and the one curb. Part of the engineering issue is that we must keep that curb very low so that if the causeway overflows, the water will be able to go across.

Kara Donsky, Woodcliff Lake, stated that they have lived in their house for 10 months and their house has flooded twice already. Her property abuts to the new development. This is very concerning. They have already lost a huge tree that came down which had been a huge buffer. Every time there is a storm, regardless of the amount of rainfall, that area is a pool. There is clearly an existing drainage issue there.

Richard Deutsch, Woodcliff Lake, asked what the status is of the abandoned gas station on Broadway and on the site of the old barn at the train station. Mayor Rendo replied that the barn had to be removed because it was falling. There are no applications now for the old barn or the gas station. Mr. Deutsch stated that they put fencing in at the old gas station. Mayor Rendo replied that our Construction Code Officials asked that they put the fencing in due to vehicles parking on the site and the trespassing that was happening as well as the garbage being left there.

Radu Kramer, Woodcliff Lake, stated that he has concern regarding a main sewer repair as well as the consequence of that. Mr. Kramer stated that he called the DPW couple of months ago and stated that there was a foul smell on the property. They came, they looked, they attempted to repair, and they could not. They called a company and they repaired it. A month later they received the bill that the town issued. There is a request for them to pay a repair on the main sewerage and there is also an allegation that some construction that they did might have contributed to the blockage that was found. Mr. Kramer stated that because of the demand for payment, an ongoing request for a permit was declined or put on hold until this issue is resolved. Regarding the issue itself, Neglia came out and looked at the situation and Dutra who did the work concluded that the property owner or his contractors could be responsible for this. Mr. Kramer stated that no such construction took place in that area in the 16 years since they moved here. If the maintenance of the main sewer were done appropriately someone could have noticed that there was debris or an obstruction. Mr. Kramer stated that they did not do any such construction at their property. All the work that they did was done with permits. Mr. Schettino responded that we have depend upon our engineer with respect to his findings and his conclusions, but certainly we will raise with him the fact that it is the homeowner's position that no work was done in that area. We will have to see if he confirms or based upon his investigation he comes to a different conclusion. We will certain bring this to his attention. Mr. Kramer stated that having the engineer look at this is not an objective way of looking at the situation. Mr. Schettino stated that the drains are engineered to sustain tremendous pressure. If our engineer concludes that some type of machine had to break this, and if in the breakage there is construction debris, it is not too far fetched that it probably came from a contractor doing work there. Mr. Kramer stated that he does not recall any neighbor doing any construction in the vicinity. But if the DPW did their job with the flushing of the main sewer, they would have observed some kind of resistance and they would have known in advance. Mayor Rendo stated that they are looking into this. Mr. Kramer asked what his permit has been on hold for 2 months.

Mayor Rendo stated that they will investigate the matter.

Alex Couto, Woodcliff Lake, stated that he would like the Mayor and Council to support the Clairmont section.

Maryann Travalja, Woodcliff Lake, stated that they are in total agreement with their neighbors who are trying to get some relief regarding the development of the Sony site. They also worry about the runoff of the site. Ms. Travalja asked what stormwater plan is in place presently. Mr. Padilla stated that it would be in place by Park Ridge. Mr. Schettino stated that a drainage plan would have had to have been approved by Park Ridge. The plan in place would not increase any runoff on the adjacent properties. If there are drainage issues caused by the work, our Borough Administrator will be contacting the engineer to have him investigate and require the developer to adhere to the requirements with respect to drainage. If the drainage plan does not accomplish as to what was testified before the Planning Board, the developer is going to have to produce another plan that meets drainage requirements. In terms of the buffer, property owners should be taking pictures of any trees damaged on any property in Woodcliff Lake, because the developer will have to replace those trees. Ms. Travalja also complained of the noise since the trees have been removed.

Jeff Bilinski, Woodcliff Lake, stated that he joined a little late and does not want to talk about the same things as everyone else but he lives on Clairmont and if he is standing in his backyard looking to the right is the Park Ridge complex and to the left is the Montvale complex and directly in front of him is the wetlands. On a rainy day it is a lake back there. He received a certified letter in the mail that had a drawing which he believes is for a flood map and drainage map and they are proposing to eliminate the total wetlands. He does not think this is right and it could make things worse. He has concerns about the 30-foot setback.

Diome Kramer, Woodcliff Lake, stated that the only construction that she is aware of that has taken place in that area/vicinity was a solid fence built by their neighbors at Amy Court.

Brian LaRose, Woodcliff Lake, stated that it is his understanding that there has been no formal site plan presented to the Planning Board in Park Ridge. It is his understanding that there has been an approval by Judge Padavano for the Fair Share Housing Settlement, but it is his understanding that there is no actual site plan that has been yet presented to the Planning Board in Park Ridge. Is that incorrect? Mr. Schettino stated that based upon what the people that are on the meeting have been saying is that construction has taken place, which is not correct. Mr. LaRose stated that the site that is being built right now is in Montvale and that has been approved. The site that they are talking about is in Park Ridge. They are not contesting what is happening in Montvale, they are already starting construction and already building. They are pre-emptively contesting what could potentially be built in Park Ridge which is a majority of the border between Woodcliff Lake and this development. In that regard, they are at the stage where they are doing work to assess whether the settlement proposed by the Fair Share Housing that has been approved by the Fair Share Housing and they are trying to assess this point with the

NJDEP to see if there are any issues with this plan. They believe that there are going to be significant issues. On that line, we should just summarize the situation at hand so that everyone is aware of where these stands. This has not been presented to the Park Ridge Planning Board. It is still in the planning stages but there is now an opportunity to present these issues with the NJDEP. In that regard, the current setback there is one hundred feet. It is made up of forty feet of grass, it is made up of sixty feet of trees and vegetation. There is also a very large grade difference in certain areas. The property in Park Ridge is significantly higher than some of the property in Woodcliff Lake. Currently, they have wetlands that are behind Mr. Belinski's house. That is still intact now. Those wetlands flow south and east, down along the Sony property in what is now a swale. There is a manmade stormwater channel with drainage and a storm drain to manage that water. It presently cannot manage the water because it is so inundated with debris. That is part of the problem. Secondly, the concern at this point is if they move that setback from one hundred feet to just thirty feet, they lost seventy feet of absorption. We have moved the higher-grade land close to the lower grade land. The amount of impervious coverage is going to increase dramatically. Mr. Schettino clarified that no work has been done on the Park Ridge property and the only work that has been going on is on the Montvale property. Mr. LaRose replied that Mr. Schettino is correct. Mr. Schettino stated that it is the Montvale development that is causing the increase in the drainage issues. Mr. LaRose stated that he believes that it could be contributing to some of the issues they are experiencing because that is where they cleared the property to the Parkway. Mr. Schettino stated that he is glad that Mr. LaRose cleared this up because we were prepared to contact Park Ridge about the drainage. Mr. LaRose stated that therefore he wanted to clarify the situation and he is the neighborhood representative on this topic if anyone has any questions his line is open. Mr. Schettino stated that we will have our engineer investigate it.

Mr. Schettino stated that every resident that received a letter should reply to the letter and focus on the drainage issue and if there is any wildlife in that area because that increases the setback and imposes further issues. The more complaints the DEP receives the better.

Mayor Rendo stated that this mayor and the council is concerned about every resident in Woodcliff Lake. In the past we have acted concerning development in Saddle River and other parts of the community. We are here to protect your interests. We are all neighbors. It impacts our property values and our way of life. He will do everything in his power to protect the interests of our residents.

MOTION to close to the public was made by Councilwoman Margolis, second by Council President Gadaleta and unanimously approved.

Mayor Rendo stated that since we have a presentation regarding Galaxy Gardens, he is not going to make any comments on his mayor's report.

COUNCIL REPORTS

Council President Gadaleta stated that she is looking forward to getting the budget passed at the next meeting in July. These are challenging times, but we are trying to do our best and be conservative as possible but also look to the future to make sure we have things in place to keep Woodcliff Lake working as efficiently and effectively as possible. Regarding the fire department, they are getting the new Chief's truck in service.

Councilwoman Higgins stated that they have started with the memory trees and are awaiting the permission from the state.

Councilwoman Margolis stated that DPW is doing ecology checks at the DPW so please get your new decal. The updated sanitation schedule is on the website and going out in the mail. There are no bulk collections in June. The next bulk collection is in July. No walking into the ecology center and no removing metal from the metal pile. Please drive slowly as camp and pool are open for the summer. Camp started today down at the pool. The pool is now open daily and through Labor Day. Shout out to the police department with their assistance and increased presence with all the end of the year school activities. With everything that is going on in the world it was appreciated. This Sunday we are going to have a celebration of visibility and inclusivity for all Woodcliff Lake residents at the pool. We are going to have music and some other activities but a time to get together with our neighbors and accept everyone for who they are, who they want to be, if they have not decided there is time, kids, adults, and all Woodcliff Lake residents are invited, and we hope to see you there.

ADMINISTRATOR'S REPORT

Mr. Padilla stated that the inclusivity day that Councilwoman Margolis spoke about is free to all Woodcliff Lake residents after 5PM that day.

CONSENT AGENDA

Councilman Schnoll stated that he wants to make sure that the Big Blue Swim School has insurance to cover us and that we are a named insured. Administrator Padilla replied yes.

MOTION to approve the Consent Agenda was made by Councilwoman Higgins, second by Councilman Schnoll, and approved by Council President Gadaleta, Councilwoman Higgins, Councilwoman Margolis, and Councilman Schnoll. Councilman Falanga and Councilwoman Hayes

were absent.

SPECIAL PRESENTATION BY MAYOR CARLOS RENDO AND FRAN REINER ON GALAXY GARDENS

Mayor Rendo thanked current and former Council members for helping us get to this point where we are today. He is going on his eighth year as mayor and as council person, we started working on this project since then. He believes that this is going to be the pride of Woodcliff Lake. He is excited about this project. We are finally going to have a public space where the community could gather and just enjoy each other's company. We are having a lot of community events, and this will be the focal point of this community. We wanted to make this park special. We wanted to make this park the envy of Bergen County. We wanted to make this park the gathering location for our entire community. We included the input of our community, by surveys, by participation in open public meetings, by putting your ideas on our Facebook pages. Mayor Rendo presented Fran Reiner who will show the presentation and describe the park and everything that is included. Mayor Rendo stated that he will then discuss the money that has been raised so far for this park.

Mr. Reiner presented the plan for Galaxy Gardens by way of video. After the presentation by Mr. Reiner, Mayor Rendo stated that they are also looking for private funds to add street trees up and down Werimus Road. We will have naming rights availability for any parts of the park. Mayor Rendo stated that we are also looking to fix up Lydecker House per the request of Councilwoman Margolis. Mayor Rendo stated that he is happy to report that Party City has agreed to donate \$250,000 to the park. We received the \$500,000 grant from Bergen County Open Space. We also received another \$125,000 from Bergen County Open Space to pay for engineering and planning services for this project. Mayor Rendo stated that he cannot divulge the name, but a resident has committed \$750,000 for this park. The resident does not want naming rights of the park. We are still in negotiations with some of our corporate partners for sponsorship. We are looking to take out a recreation bond to incorporate Lydecker and Werimus Road. Mr. Reiner went over the cost estimate for the park.

Mayor Rendo stated that the presentation that Mr. Reiner provided will be on the Borough's website.

ADJOURNMENT

MOTION to adjourn was made by Council President Gadaleta, second by Councilwoman Higgins and unanimously approved. Meeting adjourned at 9:10 PM.

WHEREAS, Juneteenth is often referred to as our country's second Independence Day and has long been celebrated among the African American community, its historical significance has largely been omitted from educational curricula, making it relatively unknown to the side population; and

WHEREAS, despite the Emancipation Proclamation by President Abraham Lincoln on January, 1, 1863, and passage of the 13th Amendment by the U.S. Congress, more than 250,000 enslaved Africans and their descendants remained in bondage in the State of Texas until the arrival of Union troops at Galveston on the 19th day of June 1865; and

WHEREAS, when the news of their emancipation spread, following the reading of "General Order Number Three" by Major General Gordon Granger, the formerly enslaved people of Texas reacted with joyous celebrations, launching what would become an annual event known as Juneteenth; and

JUNE 2022 ENGINEER'S REPORT BOROUGH OF WOODCLIFF LAKE JUNE 14, 2022



1. Causeway Streetscape Improvements

Project was awarded to Marini Brothers Construction Company Inc. for the amount of \$294,993.90. Preconstruction meeting was held on 5/9/2022 with the project anticipated to be completed this summer. Waiting on confirmation of start date with project to be completed while school is not in session.

2. Glen Road Bridge

NJDEP provided verbal approval to Neglia for the hydraulic calculations associated with the bridge replacement project on 4/6/2022 and we anticipate receipt of the permit on or about June 25, 2022. Amended bid plans, specifications, and engineer's estimate to be provided to Borough for review prior to re-bidding following receipt of the NJDEP Land Use Permit.

3. 2021 Road Program - 4 Cleanup

Milling, paving, and striping has been completed. Punch list has been provided to contractor for punch list completion followed by final invoicing and project closeout.

4. Woodcrest Drive Pumping Station

NJDEP Treatment Works Approval Application submitted to the NJDEP on 4/7/22 and is currently under review by the NJDEP. Neglia coordinating final construction drawings with pump vendor and DPW and addressing comments of the NJDEP at this time.

5. Galaxy Gardens Civil Design and NJDEP Land Use Permitting

Neglia reviewed the conceptual plans for the Galaxy Gardens park improvements and prepared a proposal for Civil Engineering Design Services and NJDEP Land Use Permitting for the project for review and consideration by the Borough. Neglia provided a preliminary concept plan showing improvements to the access to the church property for preliminary review and coordination purposes.

6. NJDOT Municipal Aid Grant - MA2023 - Campbell Avenue

Neglia will provide an engineer's estimate and supporting information to be included in your grant writers grant application submission for the Borough's NJDOT MA2023 grant application for Campbell Avenue. Should the Borough be awarded a grant for the project, Neglia would provide a proposal for the design and bidding on the project.

WHEREAS, the Open Public Meetings Act, N.J.S.A. 10:4-12, provides that an Executive Session, not open to the public, may be held for certain specified purposes when authorized by Resolution; and
