Swim Team is open to all **members of the Old Mill Pool** between the ages of 5-17. **Swim team is NOT swim lessons.** Beginners MUST be able to swim the length of one lap lane (25m) without assistance. Registered swimmers receive team shirts and an end-of-season party.

REGISTRATION: The registration fee for forms submitted between 5/1 and 6/1 is \$110 per swimmer. After 6/1, the fee is \$120 per swimmer. *Please complete a registration form (page 2) for each swimmer.*

PARENT MEETING: We will hold a parent meeting on **Saturday, 6/4 from 11:15-12pm at the Old Mill Pool Pavilion**. The meeting will start on time. All swim parents, especially those of new swimmers, are highly encouraged to attend.

PRACTICES: There will be a swim clinic for all ages on **Saturday, 6/18 from 11:15-12:30pm**. Practices will then be held daily (M-F) beginning on **Monday, 6/20**. Ages 5-10 will participate in the 5:30-6:30 practice. Ages 11-17 will be in the 6:30-7:45 practice. Swimmers cannot switch practice times because they are geared to ability levels.

SWIM MEETS: We will be having swim meets this year! **They will be on Mondays & Wednesdays in July.** There will not be practice on days when we have meets. Swimmers **must** check in by 4:20pm in order to swim in meets. <u>All swimmers are</u> <u>required to swim in at least 3 of the 5 meets.</u> If your swimmer is going to miss more than one week of our six week program due to vacation, etc., please reconsider joining.

SWIM SUIT SALE: We will hold a team swim suit sale on **Wednesday, 6/22 at the Old Mill Pool. The sale will be held from 5-7pm.** This is the *only* team-sponsored sale where swimmers can try on and purchase the team suit at the Old Mill. Cash, check, and credit cards are accepted.

VOLUNTEERS: The continued success of our team depends on parent volunteers at all swim meets. One parent per family **must volunteer for at least 2 meets** as a condition of their child's participation on the team. If parents wish, they may opt-out of 1 or both volunteer commitments by paying <u>\$25 per meet</u>, in addition to the standard registration fee. Parental opt-out fees will be used to hire college students to perform the multitude of roles which are necessary to ensure a smooth, stress-free meet.
