

# NOTICE TO WOODCLIFF LAKE DOG AND CAT OWNERS

The 2026 Rabies Clinic for dogs and cats will take place on Saturday, April 25, 2026 from 10:00 a.m. to 12:00 p.m.  
 Licensing and rabies vaccinations will take place on the front lawn at Borough Hall.  
 In the event of inclement weather, vaccinations and licensing will be done at The Borough Hall.

Dog and cat licenses must be obtained by June 1, 2026. All dogs and cats over 7 months of age are required to be licensed in the Borough of Woodcliff Lake. A canvass will be made after this date, and owners of unlicensed animals will be subject to the penalty as provided by law. There will be a late fee of \$10.00 in addition to the regular licensing fee after July 1, 2026. After August 31, 2026 a summons will be issued to owners who have not registered their pets.

Licenses may be obtained at the Borough Hall or by completing the attached application cards and mailing same with a check for the appropriate amount, together **WITH A COPY OF A VALID RABIES CERTIFICATE** proving rabies vaccine is valid through March 31, 2027.
