MAYOR'S REPORT

Mayor Rendo stated that we had a very successful kick-off for hip transportation this week. The bus is picking up our residents at the Apostolic Church. This is an application that you could book your seat on the bus and it goes to Montvale and then straight into New York City. This cuts down on commuters' commuting time, the bus is clean, and dependable. Mayor Rendo also stated that we are looking into having a stop at Borough Hall as well. Administrator Padilla stated that they are also looking into having a stop at the VFW lot since we have plenty of parking. Councilwoman Gadaleta stated that buses stop on Pascack Road near her house and it is pitch black. Is there anything that the Borough could do, perhaps put up some sort of sign that blinks, so commuters are aware that this is a bus stop or a crosswalk. There is no sidewalk there and it is very dangerous.

ADMINISTRATOR'S REPORT

Administrator Padilla stated that we advised our Engineer to go out to bid for our pool cover and the pool shell. That is going to be going out this week with a return date of late February so that it should be ready for awarding for our first meeting in March. The way that it will likely work is that the pool cover takes about 12 weeks or more to design so we will have it in time for when the pool closes. The pool shell work will be done once the pool closes in September. Our Finance Committee has been meeting on Fridays with different departments regarding the budget. Mr. Padilla stated that he is working on the Salary Ordinance and they are hoping to implement a new salary step guide for DPW. Mr. Padilla stated that we just implemented SDL at Borough Hall. We started with our building department, fire prevention and dog and cat licenses. This program integrates all the programs and is a one stop shop. Eventually, the public will be able to log into a portal and see public information. Hopefully, this will cut back on OPRA requests. Mr. Padilla thanked Debbie Dakin for overseeing the Rabies Clinic with the help of Joy Sugerman, Meg Smith and Kyle Dakin. Mr. Padilla stated that we had 2 college students interning with us during winter

break. They worked with Debbie in preparing and organizing many of our files that were able to be destroyed. Debbie was able to get permission from the State and have the records destroyed. Along with Nancy Flowers, the process was done with their records as well. The interns were also able to help organize a portion of the basement files.

Mr. Padilla stated that there is a Resolution on the Agenda to go into contract with the Apostolic Church. The agreement allows the Borough to use their parking lot for commuter parking. We picked up 8 additional spots this year. We will be taking back a few spots in the Borough Hall parking lot for Borough Hall personnel parking.

Councilwoman Hayes stated that a resident has a question on Resolution No. 20-25. Does the 3% convenience fee also apply to debit cards or is just for credit cards. Mr. Padilla stated that it is up to the bank.

Councilwoman Gadaleta asked Mr. Padilla to update the Council on the shared services agreement with Old Tappan. Mr. Padilla stated that right now there are 20-25 smaller Borough vehicles that require regular maintenance. We really don't have the manpower for this. We are looking at Old Tappan and others to see if it is cost effective to take our vehicles to them. We looked at Old Tappan because we already have a relationship with them. They are a very similar town and they have the personnel.

COUNCIL MEMBERS COMMENTS/REPORTS

Councilwoman Gross stated that we should take a moment and reflect since it is International Holocaust Remembrance Day.

Councilwoman Gadaleta stated that she spoke with Chief Burns last week regarding something that she saw on the news that piqued her interest. In Maywood, they had a police dog and distributed DNA tests (free of charge) to the senior in town and anybody with special needs. The do the test and then put it away. Should that person get lost somewhere, they have this DNA sample that the dog can come and smell and help locate the resident. Councilwoman Gadaleta asked Mr. Padilla to follow up with Chief Burns. Councilwoman Gadaleta stated that she was at the Teterboro Aircraft Abatement Advisory meeting with Warren Feldman and they are looking to do a test of having the pilots go over Route 17 if weather permitted instead of going over Woodcliff Lake. There is information that Councilwoman Gadaleta asked Tom and Elizabeth to put up on our website. There are looking for comments from the residents regarding this idea so Councilwoman Gadaleta urges everyone to please go to the website and click on the link and encourage pilots to go over Route 17. June 30th is the last day to use this link for the Route 17 suggestion.

Councilwoman Gross stated that it is always questioned why our kids go to school on Martin Luther King Day. What our school has done is make it a day of service. They provided a lot of help to many different organizations.

Council President Singleton stated that Councilman Falanga and himself are working on the Finance Committee and have started to meet with different departments regarding this year's budget. Council President Singleton thanked Mr. Padilla for setting these meetings up. We are going to bring a bipartisan budget to the residents. Both Republican and Democrat. It's not about parties, it's about what is best for the residents.

Mr. Padilla stated that all residents should be downloading the Recycle Coach app. Once you download the app and put in your town and address, it will remind you when garbage pick-up is and when recycles are getting picked up. Additionally, please do not place any snow in the middle of the street. Put the snow back onto your lawn. All residents should also remind their private landscapers or private companies. The newsletter will be going out shortly.

Walter Appelle, Woodcliff Lake, stated that the train whistle seems to be getting louder and more frequent.

MOTION to close to the public was made by Councilman Singleton, second by Councilwoman Gross and unanimously approved.



MUTUAL AID PLAN & RAPID DEPLOYMENT FORCE INTERLOCAL SERVICE AGREEMENT

JANUARY 27, 2020
RESOLUTION NO. 20-20

WHEREAS, the police departments in Bergen County have a day-to-day responsibility to provide for the security of lives and property, for the maintenance and preservation of the public peace and order; and

WHEREAS, Law Enforcement Officials also have a responsibility to provide for preparedness against natural emergencies, such as floods, hurricanes, earthquakes, major storms, etc., manmade causes, civil unrest, and civil disobedience such as riots, strikes, jail or prison riots, train wrecks, aircraft crashes, major fires, ethnic disorders, riots, terrorist incidents and bombings, state and national emergencies; and

WHEREAS, the Bergen County Police Chief's Association has proposed a Mutual Aid Plan and Rapid Deployment Force to deal with these emergencies; and

WHEREAS, this Plan will provide a uniform procedure for the coordination of the requesting, dispatching, and utilization of law enforcement personnel and equipment whenever a local law enforcement agency requires mutual aid assistance from any other jurisdiction, both contiguous and non-contiguous, in the event of an emergency, riot or disorder, in order to protect life and property; and

WHEREAS, it is the desire of the Mayor and Council of the Borough of Woodcliff Lake to participate in a Mutual Aid Plan and Rapid Deployment Force in accordance with the Plan as submitted by the Bergen County Police Chief's Association.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of Woodcliff Lake that the Police Department of the Borough of Woodcliff Lake, under the direction of the Chief of Police, cooperate with the Bergen County Police Chief's Association to create an Interlocal Services Agreement with all municipalities in the County of Bergen in order to put into place the Mutual Aid Plan and Rapid Deployment Force; and

BE IT FURTHER RESOLVED that a copy of this Resolution be forwarded to the County Executive, the Board of Chosen Freeholders, the County Prosecutor, the County Chief of Police, and all Bergen County Municipalities.



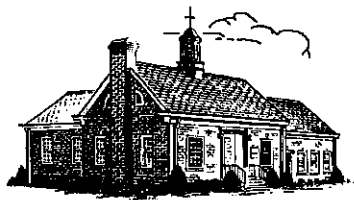

FIRE DEPARTMENT MUTUAL AID AGREEMENT BOROUGH OF WOODCLIFF LAKE

RESOLUTION NO. 20-24 JANUARY 27, 2020

WHEREAS, the Borough of Woodcliff Lake recognizes the necessity for the sharing of emergency services, aka mutual aid, to communities or districts inside and outside of the presently established Pascack Valley and Tri-Borough Mutual Aid groups, for the purpose of providing of personnel and fire rescue equipment for the period beginning January 1, 2020 through December 31, 2020; and

WHEREAS, the Borough of Woodcliff Lake's Fire Chief or the Fire Chief's designated representative will be making decisions to provide mutual aid to area communities with brief notice; and

WHEREAS, the Borough of Woodcliff Lake's Fire Chief or the Fire Chief's designated representative will insure that arrangements are made, prior to providing such mutual aid to other communities; for appropriate emergency protection for the Borough of Woodcliff Lake and its residents; and

WHEREAS, the Borough of Woodcliff Lake understands that the community region requiring mutual aid may not be adjacent to or be part of the existing Pascack Valley or Tri-Borough Mutual Aid groups already established in the Pascack Valley of Bergen County; and

WHEREAS, Worker's Compensation will be provided by the Borough of Woodcliff Lake (employer), General Liability is assumed by the recipient of the service and Automobile Liability/Physical Damage and Property Insurance stays with the owner of the property (Borough

of Woodcliff Lake).


