MAYOR AND COUNCIL MINUTES
FEBRUARY 10, 2020
7:00 PM**

CALL TO ORDER

Notice of this meeting, in accordance with the "Open Public Meetings Law, 1975, C. "231", has been posted at the Borough Hall and two newspapers, The Record and The Ridgewood News, have been notified.

ROLL CALL

Mayor Rendo asked for a roll call. Council members Falanga, Gadaleta, Gross, Hayes, Singleton and Spelling were present. Borough Attorney John Schettino was present, as well as Borough Administrator Tomas Padilla and Borough Clerk Debbie Dakin.

PLEDGE OF ALLEGIANCE

All present recited the Pledge of Allegiance.

APPROVAL OF MINUTES

Motion to approve the Minutes of January 27, 2020 was made by Councilwoman Gross, second by Council President Singleton and approved by Councilman Falanga, Councilwoman Gadaleta, Councilwoman Gross, Councilwoman Hayes, Council President Singleton and Councilman Spelling.

FIRE DEPARTMENT APPOINTMENTS

ADMINISTRATOR'S REPORT

Administrator Padilla stated that he spoke with the Fire Chief regarding the Fire Department appointments and as soon as they completed some of the required training, we will have a swearing in ceremony for these officers. Mr. Padilla stated that Dan Latanzi is here this evening. He is our LSRP and is working on Galaxy Gardens. We have been diligently working on it and Mr. Latanzi will give a brief update.

Mr. Latanzi stated that he has been working on this project for about a year now. This past summer he worked with Neglia Engineering to submit bid documents for three different phases of work. The first was for demolition of the building and site clearing. The second was for soil blending work for former pesticide contamination that was on the property. The third was for soil excavation of the property. The building has been demolished and the site cleared this past summer by the contractor. That contract is pretty much closed out. Last summer and into the fall they started with the soil blending work. That has also been completed. The third phase regarding the soil blending has also been completed. All this work is being overseen by First Environment and is being conducted in accordance with the DEP Regulations. All active work under the contract has been completed at this time. After the work is completed, the State requires follow-up testing. The testing came back favorable for the soil blending which was a major part of the remediation. That portion of the job is complete. As for the soil excavation, that work was done as well. The soil testing was favorable. The monitoring well was installed and some of the results came back above DEP limits. This is not uncommon. As the LSRP, they must further evaluate that. Mr. Latanzi will be discussing that with some of the Council members. Mr. Padilla stated that approximately 90% is completed as far as the remediation. For us to get the grant from the County, it must be certified totally clean. Mr. Padilla will be working with Dan and the county to see if we are able to secure part of that, if not, we will formally apply for another extension of time. Councilman Spelling asked Mr. Padilla if he thinks the County will push back on the extension of time request. Mr. Padilla stated that he cannot guarantee anything, but they have been very receptive if we are showing them that we are taking steps to complete the project. Councilwoman Hayes stated that we are on schedule for hydroseeding it, so we are not looking at a dirt lot. Mr. Latanzi stated that the hydroseeding is in the contract. Mr. Padilla explained that the water truck was left behind anticipating the need for it.

Mr. Padilla stated that the newsletter went out. We added a little color to try and make it more appealing. That was Councilman Gross and Elizabeth Calderone's idea to try and make it stand out. There is a communication survey in the newsletter. We ask that everyone fill it out and send it back in with your ideas.

Councilwoman Gadaleta asked Mr. Padilla if he had an update on any safety measures that the Borough might be able to make on Pascack Road regarding the buses that stop to drop off passengers. It is pitch black out and pedestrians are trying to cross the street in the pitch black. Mr. Padilla stated that he will follow up with Chief Burns if something can be done.

ENGINEER'S REPORT

Mr. Jacobs stated that the site work has been completed regarding the soil moving at Galaxy Gardens. The grass that we are putting at Galaxy Gardens is not meant to be part of the park but is a requirement of DEP and soil erosion to stabilize the site. Lincoln Avenue is going to be a joint project between Woodcliff Lake and Hillsdale. The Borough has received a grant for just over \$200,000 for the improvements for the Woodcliff Lake portion of Lincoln Avenue. We coordinated with Hillsdale and submitted the plans and specs to DOT for their approval. Once they give us their approval, we will be allowed to go out and bid and award it. Mr. Jacobs stated that he has been speak with DPW Superintendent Behrens regarding the 2020 road work. By the next meeting we should have a list. Woodcliff Lake has received a 2020 grant from the DOT for improvements to the causeway. This would involve everything outside the curb. The road itself will not be part of the project. The amount of the grant is for \$174,000. Councilman Falanga and Councilwoman Gadaleta are interested in working on this project. Mayor Rendo stated that we should try and increase that grant, \$174,000 does not get you much these days. The causeway is a County Road so perhaps we should be going to the County to see if they have any funds that could help us with that area. Councilwoman Hayes stated that the trees alone were \$80,000. Mayor Rendo stated that he likes Councilwoman Gadaleta's idea of adding banners for Woodcliff Lake. Councilwoman Gadaleta stated that we should come up with a game plan first. Councilman Falanga asked if the fencing is the responsibility of the Borough or Suez. Administrator Padilla and Evan Jacobs will investigate it. Mr. Padilla stated that perhaps Suez should be in the meeting as well. Councilwoman Grass stated that the issue on the Causeway regarding trees is that they are pear trees and they grow outward and you must keep pruning them which should be done every 5 years which they haven't been done. The additional thing is that those trees were purchased in memory of loved ones and there are plaques for them. Councilman Falanga stated that some of the plaques are worn away.

Mr. Jacobs stated that the Maria Road and Glen Road pumping stations required considerable permitting. We received all the signatures needed, including those of private property owners. All applications have been submitted to the DEP. Mr. Jacobs will keep the Borough updated. The Borough pool cover has deteriorated to the point it needs to be replaced. This project is currently out for bid and we will be opening the bids on Tuesday, February 25th. The pool shell itself needs some improvements. These improvements will begin as soon as the pool closes in September. Councilwoman Hayes asked if we are breaking up any of the concrete or are, we just plastering some cracks. Mr. Jacobs stated that some of the cracks are superficial and there are some that go deeper than just the plaster.

COUNCIL MEMBERS COMMENTS/REPORTS

Councilwoman Gross stated that we did have some people respond to our request in the newsletter about getting the word out to the public. Councilwoman Gross stated that we met with Cliffhanger regarding the Springfest. This year is going to be a little different. Before we had vendors and that didn't really work out so well in the past. We are going to focus more on food trucks and music. We are pretty sure we are going to have The Nerds. Councilwoman Gross stated that she would like to have a daytime and nighttime open forum regarding Galaxy

Gardens. This would give the residents an opportunity to give their ideas on what they would like to see there. Councilwoman Gross also stated that perhaps the Borough could look into having a Butterfly Garden in memory of Alyssa Alhadeff. Mr. Padilla will speak with Marilyn Clark and the Shade Tree Advisory Committee regarding this. Councilman Falanga stated that we could also check with the Boy Scouts and the Girl Scouts to see if they would be interested in this project. The police department have been interviewing and they will be meeting on February 26th.

Councilwoman Gadaleta stated that she spoke with Chief Burns about having DNA kits available to certain people in Woodcliff Lake. You would do the DNA swab and keep it in your house. If the person goes missing, we could then involve the County search dog or the bloodhound from Maywood. The DPW has the sweeper from Paramus going around sweeping our streets. Shredding Day is March 28th (details are on the website).

Mr. Padilla reported that Ride Hip is going well in the Borough. Besides stopping at the Apostolic Church and Borough Hall, the bus will be stopping at the VFW as well. Mr. Padilla stated that no one really parks at the VFW and perhaps the Council would like to think about allowing Park Ridge residents park in the lot.

CORRESPONDENCE

PUBLIC COMMENT

MOTION to open to the public was made by Councilwoman Gadaleta, second by Councilman Spelling and unanimously approved.

Bert Taylor, Woodcliff Lake, stated that there seems to be another delay at Galaxy Gardens. He understands that the Borough is doing the best that they can. The intersection at this site is dangerous. There is still a concern regarding the safety at this intersection. Mr. Taylor handed out a printout of the surrounding parking lots near Woodcliff Lake and how much they charge. Mr. Padilla stated that the Mayor and Council has been speaking about this subject lately. Mr. Taylor stated that there are 9 Master Gardeners on the Shade Tree Committee and hope to make some contributions to the Borough.

Veronica Appelle, Woodcliff Lake, wanted to follow-up from the last meeting regarding the property on Broadway that has the storage of vehicles. Mr. Padilla stated that our Property Maintenance Officer is handling this matter. Ms. Appelle stated that if there was a site that looked like this on Chestnut Ridge Road it was be gone by now.

Gwenn Levine, Woodcliff Lake, stated that she received a letter from Associated Appraisal Group about her new tax assessment. Her tax assessment is going to increase by 14%. The developers at 188 Broadway recently got a tax assessment decrease of about 40%. The rationale for this decrease is that the former office building is now vacant which decreases the value. There are a

few problems with this explanation because 188 Broadway is vacant intentionally because they want to convert from an office to a residence. The part-time Tax Assessor from Woodcliff Lake is shared with a few other towns including Paramus. His actual employer is the Mayor of Paramus who is one of the developers of 188 Broadway and benefited from the tax deduction. The developers of 188 Broadway got a tax deduction without ever filing a tax appeal as she understands it and that is supposed to be required procedure.

Alex Couto, Woodcliff Lake, asked if the School Board is no longer restricted to 2% increase. Mr. Schettino replied that they wanted to pass legislation to allow districts that lost a large amount of State aide to exceed the 2% cap to make up for their loss. That bill was vetoed. Locally, if you have a November election the School Board can increase the budget up to 2% without being approved by voters. Mr. Couto asked if the School Board meets regarding the budget and if he could get notices regarding it. Mayor Rendo stated that you need to reach out to the School Board to find out when their meetings are. Mr. Couto asked if there was any update regarding 188 Broadway. Mr. Schettino replied that there are 2 cases regarding 188 Broadway. There is the one in Tax Court regarding their assessment and there is one in Superior Court regarding their development. Mr. Schettino stated that right now discovery is taking place regarding the case that is in Superior Court. Mr. Couto stated that they would like to attend the court hearings to show their support for the Zoning Board. Mr. Schettino stated that they could ask the Zoning Board attorney to let them know when the case is scheduled for hearing.

Ms. Levine stated that she didn't realize that they were in Tax Court. Mr. Schettino stated that he gave a very detailed explanation several meetings ago regarding 188 Broadway.

MOTION to close to the public was made by Councilman Singleton, second by Councilwoman Gadaleta and unanimously approved.

ADJOURNMENT
