#### **APPROVAL OF MINUTES**

Motion to approve the Minutes of February 10, 2020 was made by Councilwoman Gross, second by Councilman Spelling and approved by Councilman Falanga, Councilwoman Gadaleta, Councilwoman Gross, Councilwoman Hayes, Council President Singleton and Councilman Spelling.

#### **FIRE DEPARTMENT APPOINTMENTS**

• Appointment of Thomas Dunn as a member of the Woodcliff Lake Fire Department

MOTION to appoint Thomas Dunn as a member of the Woodcliff Lake Fire Department was made by Councilwoman Gadaleta, second by Council President Singleton and unanimously approved.

#### **MAYOR'S REPORT**

Mayor Rendo stated that a few weeks ago he was over at BJs Wholesale Club and he noticed an older gentleman struggling to put his groceries up on the conveyor belt to pay. Mayor Rendo noticed that he had a WW II hat on, so he helped him with his groceries. Mayor Rendo paid for

his groceries and thanked him for his service. The gentleman sent the Mayor a nice letter and card. Mayor Rendo read the card into the record. "It was a pleasure meeting you at BJs on Sunday. Thank you for your generosity. I have included my Army history for you. Signed, Guido." Guido lives in Hillsdale.

Mayor Rendo stated that he would like to have an update at the next meeting on the Reservoir Walkway. He would like to know where we are, including the construction of the walkways. Mayor Rendo stated that he knows that there is an issue with Park Ridge on the northern part of the Causeway. If the issue continues with Park Ridge, he would like to see what the options are to at least open it up from Woodcliff Lake down to Hillsdale.

Mayor Rendo stated that we are going to strictly enforce our comments today because we need to get over to Saddle River. Mayor Rendo is going to make a comment in Saddle River so he would like to get this meeting wrapped up quickly.

Mayor Rendo stated the following: As always, I share the concerns of Woodcliff Lake residents when any potential project threatens the quality of life in our community. However, I also continue to celebrate the fact that we strive to make Woodcliff Lake a friendly and welcoming community. Being good neighbors is important to us locally, and while we normally use that to man how we treat those that live within our borders, there is no reason not to extend it geographically to neighboring municipalities. Of course, we expect the same in return. The proposed development of 24 rental units on the edge of Woodcliff Lake raises several concerns - what impact will it have on local infrastructure including streets and sewer and water lines, school system, density and flooding? Those are all issues that the Council is looking into now and issues that are open for discussion. What is the environmental impact? With these questions still unanswered, we are working with our Borough professionals to review this proposed project. It is only with this full information that we can consider a path forward. We have opened communications with Saddle River officials, and I will continue to speak directly with Mayor Albert Kurpis while I know my colleagues here on the dais, including Council President Singleton, will make sure all your voices are heard." Mayor Rendo, Council President Singleton and Councilwoman Gross met with the Mayor and two Council members from Saddle River to discuss this project.

#### **PUBLIC COMMENT**

MOTION to open to the public was made by Councilwoman Gadaleta, second by Councilman Spelling and unanimously approved.

Mayor Rendo asked all residents to be mindful that what they say. It is being recorded and part of the public record. Mayor Rendo reminded the Council that we speak as a public body, not individually.

Allison Silver, Woodcliff Lake, stated that she is here on behalf of the residents of Apple Ridge and Deerfield Roads in Woodcliff Lake, and they appreciate the opportunity to speak with the

Mayor and Council this evening regarding Saddle River's proposed affordable housing development to be built on 78 Woodcliff Lake Road. While they understand that Saddle River does not have a site plan at this time, they do have some preliminary questions they would like to raise at this time.

- 1. Do you know when Saddle River plans to have a site plan for 78 Woodcliff Lake Road?
- 2. Does Woodcliff Lake own the entirety of Apple Ridge Road? If so, is there any way that Saddle River could either open the road or put an ingress or egress onto Apple Ridge without Woodcliff Lake's consent?
- 3. Do we plan to conduct our own traffic and environmental studies? As a resident who lives directly across the street from the proposed development, Ms. Silver has not only witnessed accidents, but also constantly hears the screeching of brakes from drivers narrowly avoiding accidents on the road. She would also like to bring to everyone's attention to water problems that negatively impact her property, as well as her neighbor's property. They already have drainage issues and are concerned that the removal of a significant number of trees will only have a debilitating effect on their ability to use their outdoor space.
- 4. Like Woodcliff Lake, they know that Saddle River has very strict zoning and building ordinances in place. They hope that this proposed development will adhere to those strict policies, specifically, with regards to building height, lighting and screening for the development.

Diana DiGirolamo, Woodcliff Lake, stated that there is a house next door to her, and when they talk about drainage, this is exactly what happens when Council people do not pay attention to the changes in drainage. She complimented Mr. Padilla because the house next door to her was violating so many Ordinances and he came by with another gentleman. Ms. DiGirolamo stated that there are several requests that the plaques be replaced on the trees that are on the Causeway.

Michael Casale, Woodcliff Lake, stated that he went to the Saddle River Council meeting a few weeks ago when this was brought up and there were a lot of irate residents at the meeting. Mr. Casale had 2 questions for the Council. When we talk about being able to fight this or having conversations with Saddle River, is there anything we could do regarding the development in Saddle River besides voice our concerns and opinions. As Woodcliff Lake residents, we could go to the Council meetings, but is there anything we could do. If there isn't, is there anything that Woodcliff Lake could do to obstruct the view.

Craig Marson, Woodcliff Lake, complimented the Mayo rand Council for doing a fabulous job protesting and gathering forces to hopefully begin a dialogue with the Town. Mr. Marson stated that he would like the Mayor and Council to commit to bringing that same energy to the project on Broadway.

Alex Couto, Woodcliff Lake, congratulated the Council on what they did some time ago where we committed to building only 16 units of affordable housing units on Broadway. As a town, we did

a great job and maybe Saddle River will do the same.

MOTION to close to the public was made by Council President Singleton, second by Councilman Spelling and unanimously agreed.

#### **COUNCIL MEMBERS COMMENTS/REPORTS**

Councilwoman Hayes stated that the Pascack Hills Players is presenting Curtains March 5, 6 and 7 at 7:00 PM and March 8 at 2:00 PM. She went to the Pascack Hills Players play last year and it was phenomenal. She encourages all Woodcliff Lake residents to attend Curtains. Tickets are available online or purchased at the door.

Councilwoman Gross stated that plans are being made for Spring Fest which will be held on May 16. The Nerds will be playing. The Easter Egg Hunt will be happening at the Lydecker House on March 28. The Mayor's Wellness Challenge will begin April 19 through June 7. We are working with Park Ridge to get some other groups involved with this.

Councilwoman Gadaleta stated that she would like to report on the Fire Department. The fire department responded to 13 calls of services this past month and attended 3 drills. On February 4 the Woodcliff Lake fire department and Park Ridge fire department were requested to give mutual to Montvale. There was a driver trapped after being t-boned by a box truck. The driver was removed to a backboard. They saved a life. On February 10 Daniel Dicso passed away. Daniel lived in Woodcliff Lake for 45 years. He was a member of the fire department. He was an excaptain and current president of the Exempt Association. On February 26 the Woodcliff Lake FAST team, Firefighter Assistance and Search Team, also known as RIT, Rapid Intervention Team, was requested into Westwood. The Woodcliff Lake FAST was activated when the porch roof collapsed trapping 6 firefighters from Hillsdale and Westwood. They worked to free the trapped firefighters who were all removed within a few minutes with only minor injuries.

#### CORRESPONDENCE

#### **CONSENT AGENDA**

Mayor Rendo stated that he had a comment regarding Resolution No. 20-88, approving and appointing the commercial and residential tax appeal attorney. He noticed that John Shahdanian was being appointed to that position. Mr. Shahdanian does not have any experience in tax appeal litigation. We should put the name of the individual that will be dealing with the tax appeals and the law firm that he represents. Administrator Padilla stated that William Rupp is the attorney that will be handing the appeals and that Mr. Shahdanian is the principle in the firm. Mr. Schettino stated that Mr. Shahdanian is the point person and a principle in the firm. Mr. Schettino stated that we could have Mr. Shahdanian's name and Mr. Rupp's name in the Resolution and their firm's name. Council President Singleton stated that the firm's name is in the Resolution.

MOTION to amend Resolution No. 20-88 by adding the name of William Rupp to the Resolution was made by Council President Singleton, second by Councilwoman Hayes and unanimously approved.

Councilwoman Gadaleta stated that she has a Resolution that she would like added to the Consent Agenda. The Resolution was prepared by Borough Attorney Schettino establishing a policy for employees exempt from overtime. Councilwoman Gadaleta stated that we spoke about this in the past and if you are comfortable, she would like to add it to the Consent Agenda. If everyone would rather review the copies, we could wait until the March 16<sup>th</sup> meeting. Administrator Padilla stated that he has not seen this Resolution and asked that it be put on the next meeting. Councilwoman Gadaleta asked Mr. Schettino if he had any comment on it. Mr. Schettino stated that it is up to the Governing Body and that he only sent it to the Committee. Council President Singleton suggested that everyone read it and approve it on the 16<sup>th</sup>.

Councilwoman Gross asked that Resolution No. 20-79 be pulled from the Consent Agenda and voted on separately since she must recuse herself from it. MOTION to remove Resolution No. 20-79 was made by Council President Singleton, second by Councilman Spelling and unanimously approved.

MOTION to approve Resolution No. 20-79 was made by Councilwoman Gadaleta, second by Council President Singleton and approved by Councilman Falanga, Councilwoman Gadaleta, Councilwoman Hayes, Council President Singleton and Councilman Spelling. Councilwoman Gross abstained.

MOTION to approve the Consent Agenda as amended was made by Councilwoman Gadaleta, second by Councilwoman Gross and unanimously approved.

Craig Marson, Woodcliff Lake, stated that he has a detailed question regarding Phoenix Advisors. Clerk Dakin told Mr. Marson that he could OPRA the contract. Mr. Marson also stated that he would like to see their RFQ. Clerk Dakin told Mr. Marson that he could also OPRA that.

MOTION to close to the public was made by Councilwoman Gadaleta, second by Council President Singleton and unanimously approved.
