

BOROUGH OF WOODCLIFF LAKE SPECIAL MAYOR AND COUNCIL ZOOM MEETING MINUTES JULY 9, 2020 6:00 PM

CALL TO ORDER

Notice of this meeting, in accordance with the "Open Public Meetings Law, 1975, C. "231", has been posted at the Borough Hall and two newspapers, <u>The Record</u> and <u>The Ridgewood News</u>, have been notified. This meeting is being held via zoom and televised.

ROLL CALL

Administrator Padilla asked for a roll call. Council members Falanga, Gadaleta, Gross, Hayes, Marson and Singleton were present. Mayor Rendo was present as well as Borough Attorney John Schettino, Borough Administrator Tomas Padilla and Planning and Zoning Boards secretary Meg Smith.

Mr. Padilla stated that the reason that we are having this meeting, as you know this process has been going back and forth, and on July 7, 2020 we received a letter from Mr. John Conte, Esq. He is an attorney for our residents Philip Rodriguez and Allison Silver, and he requested that the Mayor and Council reconsider and vote to approve the settlement. We advertised in accordance with law and this meeting is solely for that reason.

Councilman Falanga stated that the 2 residents that live close to the property support the settlement, so his way of thinking has changed.

Mayor Rendo stated that we received Mr. Conte's letter and Mr. Schettino recommended the settlement so the Mayor supports the settlement agreement.
