

## BOROUGH OF WOODCLIFF LAKE MAYOR AND COUNCIL MINUTES JULY 13, 2020 5:00 PM

Mayor Rendo stated that the Mayor and Council, Borough Attorney and Borough Engineer are participating via zoom.

## **CALL TO ORDER**

Notice of this meeting, in accordance with the "Open Public Meetings Law, 1975, C. "231", has been posted at the Borough Hall and two newspapers, <u>The Record</u> and <u>The Ridgewood News</u>, have been notified. This meeting is being held via zoom and televised.

## **ROLL CALL**

Mayor Rendo asked for a roll call. Council members Falanga, Gross, Hayes, Marson and Singleton were present. Borough Attorney John Schettino was present, as well as Borough Administrator Tomas Padilla and Borough Clerk Debbie Dakin. Councilwoman Gadaleta arrived at 5:10 PM.

## **PLEDGE OF ALLEGIANCE**

All present recited the Pledge of Allegiance.

## **ENGINEER'S REPORT**

Mr. Jacobs stated that Neglia Engineering assisted the Grant Writer in applying for a grant from the NJDOT Municipal Aid Grant Program in the amount of \$174,000 towards the streetscape beautification along the Causeway. The project construction cost is estimated to be approximately \$257,400.00. The DOT grant is a reimbursement grant, so the Borough would be required to providing funding for the project and would ultimately be reimbursed after construction. It should be noted that only NJDOT-compliant items are eligible for reimbursement. Upon request, Neglia Engineering will provide surveying, engineering, bidding, and construction management services.

The contractor for Galaxy Gardens has completed virtually all the work under the original contract. Neglia Engineering understands that there is additional environmental work to be done based on the conditions encountered on-site during the work. Neglia Engineering understands

that the LSRP has provided an estimate of the cost to perform the additional remediation work in order to close out the project as a change order. The cost for the contractor is \$31,525.00, and the cost for oversight/management and closure for the LSRP is \$17,100.00. Once the change order is approved, the Contractor could commence with the final work for the site to close out Phase 1.

The contractor received the Notice to Proceed for the new pool cover. As a reminder, the low-bidder is Tri-Plex Industries with a submitted bid of \$80,637.00. The contractor will be providing a shop drawing for the new pool cover. Once received, Neglia Engineering will coordinate with the Borough for review of the same in order to release the cover for fabrication.

Construction on the Glen Road Pumping Station will commence during the week of July 13, 2020. Work is expected to last approximately two weeks, weather permitting. Intermittent road closures are to be expected during this time. The work on the Maria Road Pumping Station will commence immediately after the Glen Road station work. Maria Road is a cul-de-sac, so closures are anticipated. Once the exact construction schedule is determined, Neglia Engineering and/or the DPW will advise the Borough.

Neglia Engineering understands from Suez that for the project to proceed, final coordination between Suez and Park Ridge is required to finalize a conservation easement associated with the project. Once finalized by Park Ridge, the construction would be able to commence. Neglia Engineering will provide an update as soon as more information is available.

Neglia Engineering along with the Grant Writer applied for a streetscape beautification grant for the causeway. They estimate the cost to be approximately \$260,000. The Borough must fund this project and then gets reimbursed from NJDOT. Because this is a DOT grant, we must stick to their specifications.

Mayor Rendo asked if we could have our grant writer look at wildlife grants and other grants in addition to the one, we received. Administrator Padilla replied that we are always on the look out for anything that would fit any criteria. Councilwoman Gadaleta stated that we want this to be up to Woodcliff Lake's standards, but perhaps the Borough could scale it down a little bit to make it fit whatever grant we are getting. Councilwoman Gadaleta asked if it was even a possibility to come up with the money to bridge the gap until we get reimbursed. Administrator Padilla stated that we did not do a capital bond this year so we would have to bond it. We scaled everything back on the budget this year. Administrator Padilla suggested that this be done in a small committee format. Councilwoman Gadaleta agreed. Mayor Rendo stated that this is a county road so we should check with the county to see if they want to kick any money into this. We are beautifying their road. Councilwoman Gadaleta asked if we couldn't get the fence replaced, could we get it painted by Suez. Councilwoman Gadaleta asked Mr. Schettino if a motion could be done on this. Mr. Schettino replied yes. Councilman Falanga would like to know first whose fence it is and who is responsible for it before we make any approach. Councilwoman Gross stated that there were a lot of committee members that are interested so perhaps there is a group that would volunteer to help us. Councilwoman Gross asked Mr. Padilla if Evan was

the right person to contact Suez or perhaps, he should. Administrator Padilla stated that he certainly could reach out to his contacts. Councilwoman Gross asked what the game plan is. Mr. Schettino stated that there needs to be a motion and second to authorize pursuing contributions and a plan for the causeway. Mr. Schettino suggested that we read the deed first for language that might identify the public entity or utility company as what responsibilities they have with respect to that roadway. Administrator Padilla stated that we will look in our files here and he will reach out to Suez and circle back once we have some documentation. Councilman Marson asked if there are any naming rights or something more substantial detailing what our obligation is. Councilman Marson stated that he agrees with Mr. Schettino that we need to understand who has the initial obligation. Councilman Marson suggested that perhaps we could get corporate sponsorship for parts of it. Administrator Padilla stated that he is not sure because the roadway is owned by the County and it is a County road and the reservoir is owned by Suez. Councilwoman Gadaleta stated that she does not want this project to sit on a shelf and would like to make a motion to get this started.

MOTION to authorize the Borough Administrator and Engineer to investigate the responsibilities for the causeway and if appropriate, seek contributions and/or authorization to make improvements was made by Councilwoman Gadaleta. Administrator Padilla stated that he thinks it is premature to seek contributions when we don't know whose responsibility it is. Councilwoman Gadaleta agreed. Councilman Falanga stated that he is concerned when we talk about who is responsibility for what. He thinks we should do this more on a committee level to find out what our obligations and their obligations are. He doesn't believe we should have a conversation with Suez now about what their obligations are. Councilwoman Gadaleta asked why, because we are not going to get anything done. Councilman Falanga stated that he lives very close to the reservoir and the entire fence around the reservoir is an eyesore. It doesn't fit Woodcliff Lake. There are parts of it that are falling. They don't maintain their land; the trees are falling, and they don't clean anything up. The property that they own is not being maintained. Councilman Falanga stated that the causeway situation is very important, but he wants to make sure we are approaching it with a unifying voice. Mr. Schettino stated that he thinks there is an overlap between the causeway and the issues that Councilman Falanga mentioned. Schettino stated that he suggests the Town call Suez and tell them that they received a lot of complaints regarding maintenance of their property regarding the fence and all items just mentioned. We tell them that we do not want to escalate this by having our property maintenance code official get involved and issue a summons. Tom should be the good guy and reach out to them and say that before this becomes a problem, he wants to see if they will cooperate and take care of their property. They have a responsibility to maintain their property. If Tom has a good conversation with them and alerts them to these issues and tells them that we don't want this to go further than residents' issues, they may voluntarily do it. Mr. Schettino stated that he doesn't think we should wait until the causeway is settled because that may take months.

MOTION to authorize the Borough Administrator and Engineer to investigate responsibilities for the maintenance and improvements of the Causeway and to authorize the Borough Administrator to contact Suez Water with respect to property maintenance code issues was made by Councilwoman Gadaleta, second by Councilman Marson and approved by Councilman Falanga, Councilwoman Gadaleta, Councilwoman Gross, Councilwoman Hayes, Councilman Marson and Council President Falanga.

Neglia Engineering has coordinated with the Grant Writer and Borough Administrator to prepare and apply for funding from the Bergen County Open Space program towards a passive park, to be located at the Galaxy Gardens site. Neglia Engineering understands that the exact plan or design for the Phase II of the redevelopment has not been determined but felt that whatever type of park is installed on the site, such would be eligible for Bergen County Open Space funding. The formal application was submitted in advance of the July 1, 2020 deadline.

Councilwoman Gross asked if we could go back to Galaxy Gardens because it has been a while since we visited that. Councilwoman Gross asked if the additional contamination at the site is related to pesticides. Administrator Padilla stated that it is related to the gas station. Councilwoman Gross asked if the LSRP is confident that this should be it. Administrator Padilla stated that he is trying to get more confirmation on that. Councilwoman Gross asked how long we must wait to get more testing. Administrator Padilla replied that once that is done then there is testing and there is a time period that they must wait for DEP before it is considered closed out. Mr. Jacobs stated that they will be taking out contaminated soil and have it cleaned and then some. Councilman Falanga asked if this is the last piece environmental wise that we do on the site. Administrator Padilla stated that this was always a concern because this was the area on the building and was never able to be properly tested while the buildings were in place. They will be removing 225 tons of soil and replaced.

Neglia Engineering has coordinated with the Borough Administrator, DPW, and Grant Writer to prepare and apply for funding from the New Jersey Department of Transportation for the resurfacing of Woodmont Drive, from Chestnut Ridge Road to the cul-de-sac. The formal application was submitted in advance of the July 1, 2020 deadline.

Neglia Engineering received approval from the NJDOT to advertise and receive bids for the Lincoln Avenue project. The Borough will advertise for the bids and award the contract. The roadway is partially in Woodcliff Lake, and partially in Hillsdale. The Borough of Woodcliff Lake obtained a grant from the NJDOT Municipal Aid Grant Program for its portion of the roadway, in the amount of \$202,068.00.

The Borough previously authorized Neglia Engineering to prepare bid documents for the reconstruction of the pool shell and various features at the existing municipal pool. Neglia Engineering had previously met with the Borough as well as a potential vendor for this work. Neglia and the Borough are meeting with another potential vendor this week to see if this work can be performed under a State contract, and therefore would not need to go out to public bid. Neglia Engineering will provide an update regarding the outcome of this meeting as well as any updated cost or contract information at next month's meeting.

#### **COUNCIL MEMBERS' REPORT/COMMENTS**

Councilman Falanga stated that Councilwoman Gadaleta inquired as to if there are any town pools that might accept Woodcliff Lake residents. There were several towns that were open to accepting residents. They are in the process of putting a flyer together that highlights different club/town pool and rates. This will go out on Constant Contact and on the website.

They have also been talking about the communications board outside of the ecology center. The board does not work and there is no temporary solution. It would cost about \$4,000 to have someone come out and diagnosis it. From our view, it is an old board and we will be exploring new boards which are much more dynamic. We are exploring replacing the board and possibly getting some sponsorships. Additionally, they are speaking about where the board should be placed. Perhaps it should be moved to the Galaxy Gardens site.

The traditional Oktoberfest is not in the budget. They are looking to see if they could do some type of October Food Truck Fest which would be a minimum cost to the Borough, other than the cost for police and DPW.

Baseball and softball are getting up and running. Practices are going well from what they are told.

The newsletter will be going out shortly.

Councilman Falanga stated that the community garden is going well. There are some folks that signed up to take a plot. There are residents who are harvesting to give to the local food bank.

Councilwoman Gross stated that she wanted to piggy-back a little bit. The community garden is going well and has been fantastic. Some gardeners took additional plots for the purpose of growing crops to donate to local food banks.

Councilwoman Gross also stated that the website is being updated. This is a long process of transferring all the information.

Councilwoman Gadaleta stated that the fire department had 140 calls to date. Additionally, the DPW has extended hours on Wednesdays and check the Borough website for additional information.

#### **PUBLIC HEARING**

Administrator Padilla stated that there is a Resolution on the Agenda to apply to the Bergen County Open Space for the second phase of Galaxy. As part of that, we need to have a public hearing on it.

2020 Bergen County Trust Fund Grant Application (Municipal Program) Galaxy Gardens

Administrator Padilla stated that we are applying for a grant to the Bergen County Open Space Trust Fund. We are looking for ideas of what to apply for the Borough. Administrator Padilla, Evan Jacobs and Melani Filosa decided to apply for a grant for the next phase of Galaxy. We are still waiting to recoup some of that original grant. That was for the first part of Galaxy which was the acquisition of that property. This would be for the actual development of a recreation park. The grant program is the open space recreation, flood plain protection, farmland and historic preservation trust fund – municipal park improvement program. Our project would be the Galaxy Gardens passive recreation plan, park development project. The total we are estimating would be about \$682,200.00. This like the original is a matching grant. The grant request would be half of that at \$341,100.00. This would create a passive recreation park currently at the Galaxy Gardens site. We purchased that property and are in the process of completing the remediation. Once that is done, we would move into phase II which is the development of the park. We had to provide a concept plan which Evan helped us out on. Based on our original trust fund, the money we use must be passive recreation. Passive recreation is necessary as it provides benefits not only for residents, but to nature as well.

Councilwoman Gross asked if this ties us to what we can really do. Is this a walking trail, plantings? Administrator Padilla replied that the scope of the work includes mobilization, soil erosion and sediment control, installation of concrete sidewalk, installation of a gazebo or type structure, flagpole and lighting, irrigation system and landscaping including trees and shrubs. Site amenities including lights and monument benches. We had to give a basic concept, not a specific. We could grow that. Possibly moving our monuments from VFW and making it a memorial park. This would not prevent us from doing such. We had an inquiry from a resident who is a landscape architect to provide free of charge some concepts for this.

Councilman Marson asked if there is a specific space contemplated to benefit from this or is this a generic grant and how will it be funded from our side? Administrator Padilla stated that it is for the Galaxy Gardens property and we would most likely use money from our open space trust fund which gets replenished by about \$200,000 every year or sponsorship.

MOTION to open to the public for comments or questions on this application only was made by Councilwoman Gross, second by Councilwoman Hayes and unanimously approved.

Josephine Higgins, Woodcliff Lake, stated that she is glad that we are going for this grant. Ms. Higgins also stated that we should make sure that the veterans are part of that area.

MOTION to close to the public was made by Councilwoman Gross, second by Councilman Marson and unanimously approved by voice call vote.

#### **PUBLIC COMMENT**

Mayor Rendo asked if anyone from the public would like to call in, now is the time to do it. Administrator Padilla gave the phone number of the Council Chambers. There will be a 3-minute maximum on comments.

MOTION to open to the public was made by Councilwoman Gadaleta, second by Councilwoman Gross and unanimously approved.

No comments.

MOTION to close to the public was made by Councilwoman Gross, second by Council President Singleton and unanimously approved.
