MAYOR'S REPORT

Mayor Rendo stated that we are introducing The Redevelopment Plan for 188 Broadway today. Mayor Rendo wanted the public to understand the process of what happens. Administrator Padilla explained the process. The Redevelopment Plan will be up on our website tomorrow. Mayor Rendo stated that Councilwoman Gadaleta and himself are still working on the air traffic noise. Mayor Rendo stated that he received an email from a resident that the Master Plan recommended that we form an Economic Development Committee. To abide by the recommendations of the Master Plan, Mayor Rendo is appointing an Economic Development Committee. Council President Margolis asked what the Economic Development Committee will be looking at. Mayor Rendo replied that it is like any other Committee, it is an advisory Committee.

COUNCIL MEMBER REPORTS

Councilwoman Higgins stated that the seniors had a meeting on Thursday and Pat Schuber was the speaker. It was an excellent presentation. The Senior Association is very happy with the upgrades that are happening at the Tice Center. The Finance Committee met with all department heads regarding the budget. Negotiations are still happening with the police department. There was a Shade Tree Committee at 4 PM today. They requested that we get a trailer that we could

put a big water container with a hose to water the new trees on the causeway. Obviously this is very dangerous and we cannot do it but we need to find a way to water the trees. A lot of the plaques were not saved from the trees that had been planted on the causeway. They paid to have names engraved, herself included. Administrator Padilla stated that he has some positive news. He received word that a few of the plaques were recovered. He knows that we have some, but he does not know how many. Councilwoman Higgins stated that someone needs to look at the fence over the causeway. She does not think that it looks good.

Council President Margolis stated there is a lot of recreation stuff happening. We had our Community Tubing this past Thursday night in conjunction with the LEAD. Councilman Pollack was there as well. Our police department was there and this year we invited Montvale's DARE program joined our LEAD program and it was a great program. They raised over \$1,700 for the Tri-Boro Ambulance Corp. and they also have a large non-perishable food donation waiting at the police department. Council President Margolis stated that she also has an update from Community Day that she never gave last year. In our clothing collection last year, \$710 was donated to the food pantry as well. We are trying to give back to our community. We are still working on the rental agreement for the Tice Senior Center. We have had an amazing amount of interest with people hearing about it. We are looking to come up with a fair agreement. Our Senior Association will get to put their schedule in first and we will implement a cap on how many times someone can rent out the senior center. We have applied for grants for our tennis courts to put in some pickleball courts. We are working on implementing a keycard system at the tennis courts with a reservation system. We are working on tennis, pool and summer camp rates. Community Day is coming up on March 19th at Tice's Corner Marketplace. A sponsorship letter will be going out for all our major events. DPW is working on prepping the fields and we will be planning the Easter Egg Hunt soon.

Councilwoman Marsh stated that on February 23rd from 5:30 PM to 7:30 PM there will be ice skating at the Winter Wonderland at Van Saun Park in Paramus. We have an ice skating time reserved for our town for taking third place in the tree decorating contest. Community Day will take place on March 19th with lots of activities and we are looking for volunteers. The Recreation Department is looking to hear from our residents. There will be a meeting on February 28th in the morning and again in the evening on March 1st at the Senior Tice Center. We would love for you guys to come out and tell us what you are looking for and want to see. The next Planning Board meeting will take place on March 19th.

Councilman Pollack stated that the tubing event was fantastic and a huge success. DPW has been taking advantage of the unusually warm weather to take care of some critical needs and infrastructure around town such as filling potholes and cleaning out stormwater basins. Residents are reminded that the Shredding Event will take place on March 25th at the Ecology Center from 8 AM to 11 AM. This is available to residents only. The hazardous waste collection schedule can be found on the Borough website. While you are on the website you can check for the updated bulk cleanup dates. After 28 years of service, DPW employee Tommy Ivancich retired. We wish him the best in his retirement. The fire department has started off with an active year. There is an average of one call a day. The fire department sold t-shirts in October of

2022 for breast cancer awareness. They collected \$2,500 which was donated to the John Theurer Cancer Center, Breast Cancer Care and Research. A thank you to the fire department for hosting such a great fund-raising drive.

Councilman Schnoll stated that it is always great to go last. Everybody has already said everything that he was going to report on. Everyone is up to speed regarding 188 Broadway and the police department. Councilman Schnoll stated that Council President Margolis and Councilwoman Marsh are doing a great job with parks and recreation. Unfortunately, he did miss the tubing event.

Councilman Schnoll stated that he is voting no but would like to make a statement to the record. The reason he is voting no on this is because he believes that it is an unnecessary expansion of our police department. Two years ago we had an open captain's spot and the chief wanted us to fill it. Some were opposed but we agreed to the chief's request, and we filled it. That created other openings in the department which increases our budget on that. Last year we budgeted over \$3 million to the police department which is over 20 percent of our town's budget. This is the largest expenditure in the budget. This is a huge expansion of the police department. Not that we are necessarily voting to increase it tonight but what we are doing is creating lots of positions that can be filled in the future. His experience has always been, both in public sector and in private sector, that openings tend to be filled.

FEBRUARY 2023 ENGINEERS REPORT BOROUGH OF WOODCLIFF LAKE FEBRUARY 10, 2023



1. Glen Road Bridge

NJDOT confirmed grant extension award deadline to April 28, 2023. Neglia finalizing bid plans and specifications per latest round of NJDOT comments received on 2/6/2023. Bid opening to occur end of March for anticipated award at the 4/17/2023 Mayor and Council meeting pending receipt of a favorable with preconstruction meeting to follow thereafter.

2. Glen Road Improvements Project NJDOT FY 2022

The Borough of Woodcliff Lake received a grant in the amount of \$206,000.00 from the NJDOT to be utilized towards the repaving of Glen Road. Glen Road is approximately 1.1 miles in length and estimated construction cost to pave the entire road is approximately \$695,000. Neglia provided proposal to the Borough for survey and design. The NJDOT award deadline is October 2023. Neglia to meet with Borough to confirm scope of and limits of the paving project. Neglia to contact NJDOT to request an extension to allow additional time for construction of the Glen Road Bridge project ahead of the Glen Road paving.

3. Year 2022 Road Program - Marjo Court and Hillcrest Road Paving Project

Bid opening for the year 2022 Road Program scheduled for 2/14/2023 with anticipated award of project at the March Mayor and Council meeting pending receipt of a favorable bid.

4. Werimus Lane Pumping Station

Preliminary design alternatives and engineer's cost estimates were provided to FEMA and DPW for review as it relates to rehabilitation of the existing station.

5. Greenway/Old Farms Right of Way Vacation

Neglia completed Roadway Vacation Plan and provided to Borough Attorney on 1/13/20223 for review as it relates to the proposed paper street right of way/roadway vacation.

6. Old Barn Survey and Concept Plan

Neglia working on our boundary and topographic survey and a conceptual plan for restoration measures for review and consideration by the Borough in accordance with our proposal approved by the Borough on 12/22/2022. Neglia needs a Title Search on the property to be provided in order to complete the survey.



7. Galaxy Gardens Civil Design and NJDEP Land Use Permitting

Neglia awaiting final approved park plan to proceed with the Civil Design and NJDEP Land Use Permitting for the Project.

8. <u>Campbell Avenue Paving Project NJDOT LA-2023</u>

The Borough of Woodcliff Lake received a grant in the amount of \$203,110.00 from the NJDOT for Campbell Avenue Paving Project as per the November 23, 2022 grant award letter. Neglia will provide a proposal for bid document preparation for the Campbell Avenue Paving Project for review by the Borough in order to stay on track with the NJDOT LA 2023 award deadline of 11/23/2024.

9. Causeway Streetscape Improvements

The Woodcliff Avenue Causeway streetscape sidewalk project was completed from Mill Road to Broadway in accordance with the 2020 NJDOT Municipal Aid grant and plans and specifications prepared by Neglia. Velolia Fence replacement was completed. PSEG to complete the lighting upgrades in early 2023. NJDOT final inspection report received and Neglia working with contractor to address NJDOT comments for final closeout.

10. 2021 NJDOT and Municipal Road Program

The 2021 NJDOT and Municipal Road Program project was completed which included the paving of Winthrop Drive and Woodmont Drive in accordance with 2019 and 2021 NJDOT Municipal Aid Grants along with paving of Van Riper Lane, Rinzler Field Parking Lot, Harvard Court, Stone Ridge as per plans and specifications prepared by Neglia. Project is complete pending final NJDOT closeout.

11. Woodcrest Drive Pumping Station

Ongoing construction in accordance with plans and specifications. Generator relocation completed on 2/6/2023 and waiting on PSEG for electrical connection. Anticipated project completion in Spring 2023 pending materials and PSEG coordination.

Ordinance No. 23-01

AN ORDINANCE TO AMEND CHAPTER 5 ENTITLED "ADMINISTRATION OF GOVERNMENT" OF THE BOROUGH CODE OF THE BOROUGH OF WOODCLIFF LAKE, STATE OF NEW JERSEY

BE IT ORDAINED BY THE BOROUGH COUNCIL OF THE BOROUGH OF WOODCLIFF LAKE IN THE COUNTY OF BERGEN AND STATE OF NEW JERSEY, AS FOLLOWS:

WHEREAS, Chapter 5, of the Code of the Borough of Woodcliff Lake sets forth all regulations regarding the Administration of Government within the Borough of Woodcliff Lake; and,

BE IT ORDAINED, by the Mayor and Council of the Borough of Woodcliff Lake, County of Bergen, and State of New Jersey that those portions of the aforesaid set forth below are hereby amended as follows and that those portions of the Ordinance not set forth below shall remain unchanged.

ARTICLE XII. Police Department

5-37. Department created and positions established.

There is hereby created in and for the Borough of Woodcliff Lake a Police Department which shall consist of a maximum of the positions listed below. The Mayor and Council can appoint persons to fill these positions, together with determining their compensation, as deemed necessary for the protection of the public safety and welfare.

- A. To provide no more than one Police Chief
- B. No more than one Deputy Police Chief
- C. No more than one Captain
- D. No more than two Lieutenants
- E. No more than six Sergeants
- F. Up to fifteen Patrol Officers
- G. Up to 10% SLEO II Officers
- H. Up to two (2) SLEO III Officers

The ranks of Lieutenant, Captain and Deputy Chief are considered Command Level Personnel and no more than 3 officers will be in such level at any one time.

All prior ordinances that are inconsistent with this ordinance are repealed. All ordinances are hereby amended to be consistent with this ordinance and all ordinances, including this one, shall be construed consistent with the express purpose of this ordinance.

This ordinance shall be construed consistent with the purpose stated in section 1 hereof. Any ambiguities in this ordinance shall be construed in accordance with the purpose of this ordinance. If any part of this ordinance is invalidated by a court of competent jurisdiction, the remainder of this ordinance shall be saved to the full extent possible. This ordinance repeals provisions of the Woodcliff Lake Code only where stated herein; otherwise this ordinance is amendatory and supplementary to existing provision of the Woodcliff Lake Code.

<u>Effective Date</u>. This Ordinance shall become effective upon final approval and publication, pursuant to law, and upon completion of all outstanding cases.

A RESOLUTION PROVIDING FOR A MEETING NOT OPEN TO THE PUBLIC IN ACCORDANCE WITH THE PROVISIONS OF THE NEW JERSEY OPEN PUBLIC MEETINGS ACT, N.J.S.A. 10:4-12

RESOLUTION NO. 23-55 FEBRUARY 13, 2023

WHEREAS, the Borough of Woodcliff Lake is subject to certain requirements of the Open Public Meetings Act, N.J.S.A. 10:4-6, et seg., and

WHEREAS, the Open Public Meetings Act, N.J.S.A. 10:4-12, provides that an Executive Session, not open to the public, may be held for certain specified purposes when authorized by Resolution; and

WHEREAS, it is necessary for the Borough of Woodcliff Lake to discuss in a session not open to the public certain matters relating to the item or items authorized by N.J.S.A. 10:4-12b and designated below:

	_1. Matters Required by Law to be Confidential. Any matter which, by express provision o ral law or State statute or rule of court shall be rendered confidential or excluded from the isions of the Open Public Meetings Act.
	2. Matters Where the Release of Information Would Impair the Right to Receive Funds matter in which the release of information would impair a right to receive funds from the ernment of the United States.
an	3. Matters Involving Individual Privacy. Any material the disclosure of which constitute unwarranted invasion of individual privacy such as any records, data, reports

recommendations, or other personal material of any educational, training, social service, medical, health, custodial, child protection, rehabilitation, legal defense, welfare, housing, relocation, insurance and similar program or institution operated by a public body pertaining to any specific individual admitted to or served by such institution or program, including but not limited to information relative to the individual's personal and family circumstances, and any material pertaining to admission, discharge, treatment, progress or condition of any individual, unless the individual concerned (or, in the case of a minor or incompetent, his guardian) shall

request in writing that the same be disclosed publicly.
4. Matters Relating to Collective Bargaining Agreements. Any collective bargaining agreement, or the terms and conditions which are proposed for inclusion in any collective bargaining agreement, including the negotiation of the terms and conditions thereof with employees or representatives of employees of the public body.
5. Matters Relating to the Purchase, Lease or Acquisition of Real Property or the Investment of Public Funds. Any matter involving the purchase, lease or acquisition of real property with public funds, the setting of banking rates or investment of public funds, where it could adversely affect the public interest if discussion of such matters were disclosed specifically with respect to The minutes will be released on or before, 20 when the issues pertaining to the property located at have been approved and finalized.
6. Matters Relating to Public Safety and Property. Any tactics and techniques utilized in protecting the safety and property of the public, provided that their disclosure could impair such protection. Any investigations of violations of possible violations of the law.
X 7. Matters Relating to Litigation, Negotiations and the Attorney-Client Privilege, any pending or anticipated litigation or contract negotiation in which the public body is or may become a party. Any matters falling within the attorney-client privilege, to the extent that confidentiality is required in order for the attorney to exercise his ethical duties as a lawyer, specifically with respect to: Contract Negotiations; Litigation Update
The minutes will be released in approximately ninety (90) days or upon the resolution through

settlement or court decision and the time period for any and all appeals.

____ 8. Matters Relating to the Employment Relationship. Any matter involving the employment, appointment, termination of employment, terms and conditions of employment, evaluation of the performance of promotion or disciplining of any specific prospective public officer or employee or current public officer or employee employed or appointed by the public body, unless all the individual employees or appointees whose rights could be adversely affected request in writing that such matter or matters be discussed at a public meeting, specifically: personnel discussion.

The minutes will be released within ninety (90) days or earlier upon the resolution of the matter through settlement or court decision and the time period for any and all appeals.

_____9. Matters Relating to the Potential Imposition of a Penalty. Any deliberations of a public body occurring after a public hearing that may result in the imposition of a specific civil penalty upon the responding party or the suspension or loss of a license or permit belonging to the responding party bears responsibility.

NOW THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Borough of Woodcliff Lake, assembled in public session on February 13, 2023 that an Executive Session closed to the public shall be held on February 13, 2023 at 6:00 P.M. at the Borough of Woodcliff Lake regarding the discussion of matters relating to the specific items designated above.
